Pet Country Spa Boarding Fees

Canine: Under 100 lbs.--\$20.00 per day...per dog
Over 100 lbs.--\$25.00 per day...per dog

Feline: All cats are \$14.50 per day...per cat

All unaltered animals will be charged an additional \$5.00 per day.

Medication to be given is an additional fee of \$5.00 per day.

If bedding is chewed or destroyed, there will be a \$5.00 fee.

Check-In Time: Day one is a full day rate and you must be here by 5:30 pm.

Check-Out Time: Monday-Saturday...before 1:00 pm.
After 1:00 pm you will be charged for the full day rate.

Sunday is always a full day charge.
Day Care is \$15.00.

Hours: Monday-Friday 7:00 am—6:00 pm
Saturday 7:30 am—2:00 pm
Sunday is pick up only 4:00 pm—6:00 pm

Pet Country Spa Vaccination Requirements

Kennel Animals: copy of vaccination history

Feline Annual Package: Rabies, Eclipse 4, Bordetella and Fecal

Canine Annual Package: Rabies, 5cv, Influenza, and Heartworm Occult (yearly)

Bordetella and Fecal are required every 6 months.

We strongly recommend the Lymes vaccine to prevent tick borne disease.

All pets are required to be current on a topical flea/tick control.

Grooming dogs must be current on Rabies, 5cv and Bordetella.

Grooming cats must be current on Rabies, Eclipse 4 and Feline Bordetella.

A courtesy exception can be made on grooming animals on the **first visit only** if the owner states that vaccinations are current. Vaccinations must be current or owner must provide proof of current vaccinations by the second visit.

We must have in file and posted in computer:

- updated vaccination records
- current address/phone numbers for owner and/or emergency contact
- current copy of valid ID or valid Driver's License

We are responsible for providing the best care possible. Illness will be treated at the owner's expense. Owners will be notified of any emergency issues if possible at the number(s) provided by the client.

**Pet Country Spa
Contract of Agreement for Services**

1. Fees are per pet, not per room.
2. A photo copy of your driver's license is required when boarding your pet. A 48 hour cancellation notice is requested so that we may open your reservation to another pet(s).
3. We need basic up to date immunization records for your pet(s). These immunizations must include a 6 month bordetella (kennel cough) as well as a 6 month fecal exam.
4. Signed Contract of Agreement gives permission from the owner to Pet Country Spa to act on their behalf in case of injury or ailment. Owner is agreeing to have Pet Country Spa act on their behalf to provide and/or seek medical advice/treatment when necessary in their absence. An attempt will be made to contact the owner of the pet(s) at the contact numbers made available to Pet

Pet Country Spa. Owner fully understands and agrees that if they cannot be reached or the situation does not allow for time to reach the owner, Pet Country Spa will take care of the medical needs of the pet(s) and the owner will be responsible for reimbursement of vet expenses/medications and follow up care of the pet(s). Owner is responsible of full reimbursement of expenses incurred during their absence to care for their pet(s). Pet Country Spa is not responsible for injury, illness, or death to any pet(s) during, or following their stay here at Pet Country Spa.

5. If your pet(s) injures another client or an employee, you will be responsible for any expenses incurred as a result. If quarantine for your pet is warranted as regulated by Texas State Law, you will be responsible for the additional fees of quarantine.
6. Pet Country Spa requires all paperwork to be completed and signed before pet(s) can be left at Pet Country Spa. Paperwork and immunization records on file should be updated as changes are made.
7. If your pet(s) have fleas, Pet Country Spa will administer Capstar to your pet(s) for a fee. Please notify us if you think your pet(s) has a flea problem as a consideration toward all other clients staying with us.
8. Upon request Pet Country Spa will bathe/groom your pet(s). Charges will vary according to size, breed, and services provided. If your pet(s) requires bathing during their stay, they will be bathed at the owner's expense.
9. Any special needs or instructions for your pet(s) must be given at time of drop off. Owner is responsible for informing Pet Country Spa of any special conditions your pet(s) may be sensitive to, or any special considerations your pet(s) may need.
10. Pet Country Spa will administer medications if full instructions are provided with medications. If pet(s) require administration of medications there will be additional charges. Please bring only the amount of medication needed for the days your pet(s) will be staying with us plus a 2 day emergency supply.
11. FOOD...We feed Royal Canin Digestive Low Fat. Some pets do get diarrhea with food changes. If you feed a different food, please bring it pre-packaged for each day your pet(s) will be with us plus a 2 day emergency supply.
12. Owners do not need to bring personal items for their pet(s). We will provide everything your pet(s) needs during their stay. If you decide your pet(s) can't be without an item, please make sure all items are labeled with pet's name. Pet Country Spa cannot be responsible for lost or damaged items. All pets must be

brought in on a leash or carried. You may keep your leash and collar. We will give you a complimentary leash to go home if you forget yours.
